Dennis Geesaman motioned to approve the minutes of the June 10, 2013 regular Meeting and the June 2013 Financial Report. Catherine Steinhauser seconded the motion. None opposed. Motion carried.

- 7-2013.1. Bryan Milson motioned to appoint Matt Freytag to serve as Councilmember for the City of Flatonia until the next Flatonia Municipal Election in May of 2014. Catherine Steinhauser seconded the motion. None opposed. Motion carried.
- 7-2013.2. Dennis Geesaman motioned to re-appoint Bryan Milson, Shawn Bruns and Vincent Ramirez and appoint Kate Horn to serve on the Flatonia Park Committee beginning in July of 2013 and ending in July of 2015. Bryan Milson seconded the motion. None opposed. Motion carried.
- 7-2013.3. Dennis Geesaman motioned to adopt the ordinance amending the bulk water rates and tapping fees. Catherine Steinhauser seconded the motion. None opposed. Motion carried.
- 7-2013.4. Dennis Geesaman motioned to adopt the ordinance amending procedures for insufficient funds charge for utility payments as amended. Catherine Steinhauser seconded the motion. None opposed. Motion carried.
- 7-2013.5. No action was taken on the establishment of a city sponsored Movies on Main Program. This is slated to be discussed in the budget process.
- 7-2013.6. Dennis Geesaman motioned to move the location of the new fire station to a location on Old Hallettsville Rd. Catherine Steinhauser seconded the motion. Catherine Steinhauser and Dennis Geesaman vote in favor. Bryan Milson and Matt Freytag are opposed. Motion fails. New Fire Station location will remain on E South Main St. in the downtown area.
- 7-2013.7. Dennis Geesaman motioned to place the new Flatonia Police Department adjacent to the new fire station on E South Main, in the downtown area. Catherine Steinhauser seconded the motion. None opposed. Motion carried.
- 7-2013.8. Catherine Steinhauser motioned to authorize City Attorney Beck to re-work the ordinance to authorize the city manager to hire and fire the police chief. Dennis Geesaman seconded the motion. None opposed. Motion carried.
- 7-2013.9. Dennis Geesaman motioned to authorize the city manager to sign the agreement with Colorado Valley Communications, Inc. for the use of city-owned antenna space. Catherine Steinhauser seconded the motion. None opposed. Motion carried.
