- 2-2011.3 Kathy Collins motioned to authorize Don Cruse, appellate counsel, to waive the filing of a response to the petition for review filed by Robert Wood in the Texas Supreme Court at this time and to further authorize him to file a response if requested to do so by the Supreme Court, also to authorize City Attorney Angela Beck to bring back to the Council a proposal to seek all monies owed to the City,

including interest as awarded by the appellate Court. Bryan Milson seconded the motion. Jan Lahodny and Tyler Mica opposed. Motion carried.

- 2-2011.5 Bryan Milson motioned to approve the ordinance rezoning PIDs 27756, 27757 and 27758 from Central Business District to General Commercial. Kathy Collins seconded the motion. None opposed. Motion carried.
- 2-2011.6 Teri Wilks motioned to approve the recommendation from the Flatonia Housing Authority to appoint Barbara Branecky and Estella Velasquez to the Board of Directors. Bryan Milson seconded the motion. None opposed. Motion carried.
- 2-2011.7 Kathy Collins motioned to approve the cross connection ordinance. Bryan Milson seconded the motion. None opposed. Motion carried.
- 2-2011.8 Bryan Milson motioned to approve the addendum to the Hotel Occupancy Tax Contracts. Kathy Collins seconded the motion. None opposed. Motion carried.
