Opening Agenda

Call to Order

Mayor Mica called the meeting to order at 6:00 p.m.

Invocation and Pledge

Citizen's Participation

Alan Weiss questioned the policy by which The Outhouse Company is utilizing the City of Flatonia's wastewater treatment

plant.

Reports

Council Members' Reports Kathy Collins reported that Mark Eversole, President of the Flatonia Amtrak Task Force, and his team have been invited to Amtrak's Texas Eagle Lines meeting in San Antonio in February. Amtrak officials will be visiting Flatonia the day before the meeting. Collins reported that she'd spoken to Bill Glavin, the Rail Division Head of Texas Department of Transportation to let him know of the progress on this project. Mr. Glavin will be speaking at the Texas Rail Advocacy Group symposium that she will be attending. Collins further reported that the Capital Area Transportation System is seeking grant funding for the depot project on the City's behalf and they are expecting the estimates to

come on the cost for the building shortly. There will be another meeting with CARTS in January.

Councilman Milson reported that there had been two work days at Central Park. The gazebo is almost complete and the block building had been emptied and painted.

Police Chief's Report

Chief Noak presented the November 2010 Police Report.

City Manager's Report

City Manager Knight reported that the City had received a notice to proceed on the arsenic project from the Texas Commission on Environmental Quality. The parts have been ordered by Layne and construction should begin in January. This will hopefully be completed during the first quarter. Staff is hopeful that the testing will then be complete by the end of the second quarter of this year.

Knight also reported that the Notice to Proceed had been received on the Downtown Trails Grant.

Knight further reported that the fences now need to go up and the enclosures completed at the new warehouse buildings.

Knight lastly reported that Kent Milson will be working with him on the 2020 Comprehensive Plan and he is hopeful to have a draft to present to Council at the February 2011 meeting.
