- 6-2010.9 Kathy Collins motioned to adopt the ordinance changing the zoning on the City property discussed above to Public Use. Teri Wilks seconded the motion. None opposed. Motion carried.
- 6-2010.10 Teri Wilks motioned to allow a conditional use permit to Katherine Geesaman to operate a bed and breakfast on her property located at 118 E 6<sup>th</sup> Street. Bryan Milson seconded the motion. None opposed. Motion carried.
- 6-2010.11 Teri Wilks motioned to direct the Nuisance Property Committee to review the complaints and the issue of livestock in the Flatonia city limits and bring a recommendation back to Council. Kathy Collins seconded the motion. None opposed. Motion carried.
- 6-2010.12 Teri Wilks motioned to appoint Jan Lahodny as the Council Representative/Chairperson on the Nuisance Property Committee and to expand in to include Mayor Scott Mica. Kathy Collins seconded the motion. There was some discussion. None opposed. Motion carried.


