Reports

Police Chief's Report

Chief Kram reported a scam that involved calls stating they were from the City and that the utilities were going to be disconnected if they didn't go to the Dollar Store to pay it. Staff was asked to put a notice on the City Manager and City of Flatonia Facebook page notifying people that this is a scam.

Donna Cockrell asked about accidents that occur at FM 609 and I10 and what could be done to get a stop light at that intersection. City Manager McLaughlin and Police Chief Kram are already working to try to get one.

Chief Kram also reported that he'd been able to get all of the abandoned cars removed from TimeWise. He also reported that he'd had some success on clean up requests at residences.

Flatonia Fire and Rescue Annual Report

The full report is in the council packet. The report shows a 20% increase in runs over 2016. One-third of these calls are within the city limits. Two-thirds of these calls are in the county.

Building Official Annual Report

Greg Robinson reported on the 2017 building permits within the city limits. The written report was presented with the packet.

Consent Agenda

Donna Cockrell motioned to approve the minutes of the December 12, 2017 Regular Meeting and the December 21, 2017 Special Meeting. Catherine Steinhauser seconded the motion. None opposed. Motion carried.

- No action was taken on the recommendation to the City Council to authorize the 1-2018.4. city manager to submit IRS Form 1023 establishing the Flatonia Economic Development Corporation as a 501(c)(3) non-profit organization.
