Councilwoman Sears motioned to approve the July 2024 financial statements. Councilman Homan seconded the motion. None opposed. Motion carried unanimously.

#### Discussion Agenda

D1.

Casey Ring from the Chamber of Commerce and Judy Pate from the EA Arnim Museum and Archives submitted requests for a raise in the maximum allowable amount receivable per quarter from the Hotel Occupancy Tax in their contracts. City Manager Bishop expressed concerns about the HOT spending. Mayor Seale requested that each entity send a calendar of events when they submit their quarterly expenditure reports. The Council will vote on the Promotion and Tourism contracts in the next meeting.

D2.

Councilwoman Sears informed the Council that the Economic Development Corporation board voted in June to amend their by-laws only to require one Councilmember. Mayor Pro Tem Eversole opposed this change. The Council will vote on the change at the next regular meeting.

#### **Deliberation Agenda**

DA8.2.2024.1

Mayor Seale requested a comparison of the previous fees to the proposed changes. He also asked that "Residential" be added to Section 4 to clarify the list of fees. Councilwoman Sears motioned to approve Ordinance 2024.8.1, an ordinance amending permit fees. Councilwoman Cockrell seconded the motion. None opposed. Motion carried unanimously with the requested change.

DA8.2.2024.2

City Manager Bishop informed the Council that the previously requested change has been made. City Secretary Ott will meet with each employee to go over the explanation and proposed pay scale to ensure everyone understands the pay scale and has the necessary information to make an informed choice. Mayor Pro Tem Eversole motioned to approve Resolution 2024.8.1, a resolution to adopt a salary scale for City employees. Councilman Homan seconded the motion. None opposed. Motion carried unanimously.

DA8.2.2024.3

Councilman Homan presented Resolution 2024.8.2, a non-binding resolution opposing commercial wind turbine projects in Fayette County and surrounding areas. He has heard opposition from Flatonia citizens and would like to represent that opinion formally. Mayor Pro Tem Eversole expressed concern because no facts have been presented to support the

resolution. Councilwoman Sears stated that she opposed the resolution because this issue does not affect the city in any way. It is a county issue, which the Fayette County Commissioners Court has already addressed. Mayor Seale suggested contacting the county for the information they received and possibly holding a public hearing to determine the position of Flatonia's citizens. No action was taken at this time.



Hello Jackie -

The Finance Committee met last night and we have our HOT funds budget ready as well as our proposed changes to the Agreement for Promotion and Tourism for October 2024 - September 2027. With the current rate of inflation expected to stay on trend, and the fact that we have been at the current fund cap in Section II for two years now, we request an increase from \$33,750 to \$39,000. This is reflected in our budget submission where we forecast our *recurring* charges for *this* fiscal year to be \$36,875. Included in our budget are funds for *one-time* expenses totaling \$12,000. Overall, our ask for this year is \$48,875.

#### **Ordinance # 2024.8.2**

AN ORDINANCE LEVYING AD VALOREM TAXES FOR USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF FLATONIA, TEXAS FOR THE 2024-2025 FISCAL YEAR; PROVIDING FOR APPORTIONING EACH LEVY FOR SPECIFIC PURPOSES; PROVIDING WHEN TAXES SHALL BECOME DUE AND WHEN SAME SHALL BECOME DELINQUENT IF NOT PAID. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FLATONIA, TEXAS:

WHEREAS, the City of Flatonia, Texas ("City") depends on property taxes to obtain income for the necessary operating expenses of the City; and

**WHEREAS**, the City is authorized by the State of Texas to assess property taxes for such purpose; and

WHEREAS, the cost of funding public safety programs and additional city staffing hours has increased; and

WHEREAS, all provisions of the Truth in Taxation Laws of the State of Texas concerning the computation of the tax rate, the establishment of the proposed tax rate, and the posting of required notices therefor have been duly met in good faith; and

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FLATONIA, TEXAS:

**SECTION 1:** That there is hereby levied and there shall be collected for the use and support of the municipal government of the City of Flatonia, Texas, for the 2024-2025 Fiscal Year, upon all property, real, personal, and mixed, within the corporate limits of said City subject to taxation, a tax of \$0.28359 on each \$100.00 valuation of property, said tax being so levied and apportioned:

For the maintenance and support of the general government (General Fund), \$ 0.28733 on each \$100.00 valuation of property.

For the Interest and Sinking Fund, \$0 on each \$100.00 property valuation.

**SECTION 2:** That taxes levied under this ordinance shall be due October 1, 2024, and if not paid on or before January 31, 2025, shall immediately become delinquent.

**SECTION 3:** That all taxes shall become a lien upon the property against which assessed, and the Fayette County Tax Appraisal District is hereby authorized and empowered to enforce the collection of such taxes according to the Constitution and laws of the State of Texas and Ordinances of the City of Flatonia, Texas. The Fayette County Tax Appraisal District, by virtue of the tax rolls certified, is hereby authorized and empowered to fix and establish a lien by levying upon such property, whether real, personal, or mixed, for payment of said taxes, penalty, and interest, and, the interest and penalty collected from such delinquent taxes shall be apportioned to

the General Fund of the City of Flatonia, Texas. All delinquent taxes shall bear interest from the date of delinquency at the rate prescribed by state law.

**SECTION 4.** That this ordinance shall become effect from and after its passage.

#### **RESOLUTION #2024.8.3**

A RESOLUTION OF THE CITY OF FLATONIA, TEXAS, AUTHORIZING THE CITY MANAGER AND MAYOR TO ENTER INTO A CONTRACT TO TRANSFER OWNERSHIP OF THE SOFTBALL FIELD AT MCWHIRTER PARK TO THE FLATONIA INDEPENDENT SCHOOL DISTRICT

WHEREAS, the softball ballfield currently owned by the City of Flatonia (hereinafter "City") and located at McWhirter Park cannot be used for any other purpose under their current zoning and applicable laws;

WHEREAS, the Flatonia Independent School District (hereinafter "District") has the power of eminent domain under Texas Law;

WHEREAS, the District currently uses and maintains the softball field at its own expense;

WHEREAS, the softball field requires significant re-grading and other work requiring considerable financial investment;

WHEREAS, the District desires to perform the required work to repair and improve the softball field for its own use as well as ongoing public use;

WHEREAS, the District cannot invest the level of money required into land that they do not own;

**WHEREAS**, the City Council held a public hearing on the issue of the transfer on June 21, 2023;

WHEREAS, the City desires to transfer the softball field to the District in accordance with § 272.001(b)(1) and (5), Texas Local Government Code, as well as in accordance with the terms and conditions as set forth herein;

# NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FLATONIA, TEXAS, THAT:

- Findings of Fact. The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes as findings of fact.
- 2. Action Authorized. The City Manager and Mayor are hereby authorized to take all steps necessary to transfer ownership of the softball field to the District pursuant to Sections

272.001(b)(1) and (5) of the Texas Local Government Code. The Mayor is authorized to enter into agreements to effectuate the transfer on behalf of the City.

3. Value Determined; How Transfer Effectuated. The District had an appraisal performed on the softball field, which resulted in a valuation of \$50,000.00. Such valuation and ultimate "payment" of such valuation shall be addressed as "credits" given for the various ongoing permanent improvements to be made by the District related to the softball field. Upon reaching a final total of "credits" reaching \$50,000.00, the softball field shall be transferred to the FISD in the form of a Special Warranty Deed. No actual money shall be exchanged between the Parties.
