### **Consent Agenda**

Donna Cockrell motioned to approve the minutes of the January 10, 2017 Regular Meeting and January 16, 17 and 24, 2017 Special Meetings and the Hotel Occupancy Tax Expenditure Reports from the E.A. Arnim Archives and Museum and Flatonia Special Projects. Ginny Sears seconded the motion. None opposed. Motion carried.

# **Deliberation Agenda**

- 2-2017.1 No action was taken on the FY 2016 Audit. Audit was not ready for presentation to Council at this meeting.
- 2-2017.2 Ginny Sears motioned to accept the 2016 Racial Profiling Report from the Flatonia Police Department. Catherine Steinhauser seconded the motion. None opposed. Motion carried.
- 2-2017.3 Catherine Steinhauser motioned to accept the bid of \$1300 from Alexander Metcalf for property identified by the Fayette Appraisal District Property ID of R51390 as currently owned by Fayette County, Flatonia ISD and the City of Flatonia. Mark Eversole seconded the motion. None opposed. Motion carried.
- 2-2017.4 Donna Cockrell motioned to authorize Mayor Milson to call and order the Flatonia Municipal Election to be held on May 6, 2017. Catherine Steinhauser seconded the motion. None opposed. Motion carried.
- 2-2017.5 Dennis Geesaman motioned to adopt the ordinance calling aq special election with a combined ballot pursuant to Section 321.409 of the Texas Tax Code to determine whether the citizens desire to abolish the current one half of one percent sales and use tax allocated for property tax relief and adopt a section 4B Sales and Use Tax of one half of one percent to create an Economic Development Corporation (Type B) pursuant to Local Government Code, Title 12, in order to undertake projects for the purposed of economic development as described in Section 505, Type B Corporations, Local Government Code, formerly Section 2(11) and Section 4B of Article 5190.6 of the Texas Revised Civil Statutes: setting the date and the polling place location for this election. Ginny Sears seconded the motion. None opposed. Motion carried.
- 2-2017.6 Catherine Steinhauser motioned to adopt the ordinance annexing the territory described herein, to the City of Flatonia, Fayette County, Texas, extending the boundary limits of said city to include the territory described within the city limits of said city and granting to all inhabitants of the territory described all of the rights and privileges of citizens of the City of Flatonia while binding them by all the acts, ordinances, resolutions and regulations of the City of Flatonia. Donna Cockrell seconded the motion. None opposed. Motion carried.
