Opening Agenda

Mayor Milson called the meeting to order at 6:00 p.m.

City Manager Scott Dixon led the invocation

Mayor Milson led the Pledge of Allegiance to the American Flag and the Pledge to the Texas Flag.

Citizen's Participation

Kathryn Geesaman spoke in opposition to the establishment of minimum standards for hotel and lodging businesses.

Alfred Dierschke spoke concerning the flooding issues on 9th Street.

Reports

The April 2015 Police Activity Report was presented to Council in the agenda packets by Chief Mike Noak. Noak further reported that the new laptops had not arrived as of yet. Noak further discussed several code enforcement issues in regards to weedy lots. He also discussed the process of putting a lien on property and the process for doing so.

The Building Permit Reports for March and April were presented to Council in the agenda packets by Code Compliance Officer Gregory Robinson.

Utility Director Jack Pavlas reported on the water tank projects currently going on (Southside tank and East Tank). Both are moving along and should be back in service in the next month to six weeks. Pavlas further reported that the lightning storm that Flatonia experienced on May 18th caused some issues with the Eastern most well as it was struck by lightning or lightning struck close by and caused some major issues. They have now been resolved.

City Manager Scott Dixon Report

Dixon reported that there are some issues with code enforcement that staff is working through.

Dixon also reported that the title of Reserve Sergeant had been given to _____, one of our reserve officers. He also reported the Officer Liz Krieg had been promoted to the rank of Corporal and will be in a supervisory role.

Dixon further reported that the new City website was up and running. Staff will be adding content to the site.

Dixon reported that the testing of the Emergency Siren had gone well. The test shows that there are areas of town where the siren cannot be adequately heard. He is looking into ways to improve it.

Dixon stated that there was a new letter in the packet that addresses two primary concerns with the Flatonia stop.

Dixon shared that he had contacted the County to see what they would be able to help out with on the street project and when they'd be able to help. He is waiting for word back.

Dixon shared that information on the Regional Airport meeting was in the packet.

Dixon reported that the City did not receive the planning grant that we had applied for.

Dixon discussed the possibility of taking a water line out to Whispering Hills on FM 609.
