Fire Department Report

Mike Whitten reported that a meeting had been held with the County Commissioner to let him know what the plans were on the Emergency Services District and he had requested to be kept in the loop on the progress. He also reported that potential Emergency Services District Task Force members had been contacted. A meeting will be held on October 6th at 7 pm at the Fire Station on Hwy 90.

City Manager Report City Manager Dixon reported on the body camera program for police officers. He also reported that there had been a concern expressed by a citizen about the different speed limits on FM 609 vs. USH 95 within the city limits. Dixon also discussed a concern that Chief Noak had expressed about the limits put on the size of the Reserve Police Force within the code of ordinances. Dixon further reported that he was getting quotes on putting the City Hall sign up that had been promised from the company that built the new police and fire station. Dixon also reported on the status of the First St. paving project. Dixon lastly reported that a new reverse 911 system was being activated through the Capital Area Council of Government and Flatonia will be participating in it. City Secretary Brunner and he will be receiving training on it in the near future.
