- 11-2014.11. Dennis Geesaman motioned to authorize staff to prepare the necessary resolution to declare the property in the M. Muldoon League originally deeded to the City for a water well to be surplus and not essential to the operations of the City and to thereafter convey the property to abutting landowners in compliance with the law.
