Opening Agenda

Call to Order

Mayor Hairgrove called the meeting to order at 6:03 p.m. Invocation and Pledge Mayor Hairgrove led the invocation and the Pledge of Allegiance.

Reports

Council Members' Activity Reports

Mark Eversole reported that there would be another Clean up Day at Rest Haven Cemetery on April 24th at 8 a.m. Eversole also reported that there would be a ribbon cutting for the cemetery on May 15th at 10 am and then move to St. Paul AME for a service.

Kathy Collins reported that the Parks Committee had held a Special meeting to discuss the Seven Acre Park and commended the youth advisors to the committee on the skate park for their help.

Len Waska reported that the deadline for turning in census materials was on April 1st. Only 66% of Flatonia had reported as of this meeting. May and June will be the time that census workers will be knocking on doors to get information on those who had not turned in their

information. Waska further reported that 2020 Comprehensive Plan Committee had held another Town Hall Meeting on March 27th to discuss Community Development. The Committee will meet with the Economic Development Commission, the Planning and Zoning Commission and the Parks Committee in the next month or so.

City Manager's Report

City Manager Kenneth Knight reported Texas commission on Environmental Quality should be giving the City an answer on going forward with the Arsenic Abatement Project by Friday, April 22nd.

Police Chief's Report

Chief Noak presented his March 2010 activity report. Noak further reported that the grant from the National Rifle Association of \$9020 the total that had been applied for would be used for more ammunition and weapons.

City Secretary's Report

City Secretary Brunner reported that the early voting for the May 8^{th} Municipal Election would be held April 26-30 from 8 am -5 pm and May 3 and 4 from 7 am -7 pm. On Election Day, polls will be open from 7 am -7 pm and the voting for both the City Council and Flatonia ISD School Board will take place in Council Chambers.

Flatonia VFD Fire Chief's Report

Fire Department member Gregory Robinson reported that the donations from the first quarter of 2010 were \$2,255.82. This brings the total in that account to \$19,378.87.

Economic Development

Economic Development Commission Chair Bob Duncan reported that the commission had almost met all of its short term goals. The Business Assistance Program has awarded \$2,330 to several businesses in town.
