Opening Agenda

Call to Order

Mayor Hairgrove called the meeting to order at 6:03 p.m. Invocation and Pledge Code Compliance Officer Gregory Robinson led the invocation and Mayor Hairgrove led the pledge of allegiance.

Reports

Council Members' Activity Reports

Mark Eversole reported that the Code Compliance Committee had met and prioritized properties that had issues that needed to be addressed. Three letters had gone out to the owners of buildings. Chief Noak has also given "friendly some reminders" to owners of neglected/abandoned vehicles.

Kathy Collins reported that there would be a new gazebo installed in Central Park. The Parks Committee will be power washing and repainting the gazebo located downtown. The committee will also be discussing an email received about the skate park at their meeting.

Len Waska reported that the 2020 Comprehensive Plan Committee had gone over the surveys that had been sent out in the utility bills. The surveys showed that there was a lot of interest in economic development. Waska further

announced that there had been a Town Hall meeting on February 27th at 9 am focusing on economic development. He further reported that there would be another Town Hall meeting on March 27th again at 9 am to discuss community development issues that would need to be addressed in the plan.

Hairgrove also recommended that all Council members review the open records and open meetings requirements again. There will be a training if anyone is interested on March 30th.

City Manager's Report

City Manager Kenneth Knight reported that the bids for the new city warehouse complex are due on March 23rd.

Knight also reported that we were waiting for the appraisal on the park land to make the next move on the parks grant.

Knight further reported that the City was still waiting on word from Texas Commission on Environmental Quality before we can move forward with the arsenic abatement project.

Knight also reported that there was a leak on the work done last year on the downtown water tower. The City is awaiting quotes on repair of the leak and on re-lettering the "Flatonia" on the tower.

Lastly, Knight reported that the City was still in the administrative process of the Community Development Block Grant that it was awarded last year.

Police Chief's Report

Chief Noak presented his February 2010 activity report.

City Secretary's Report

City Secretary Brunner reported that the candidates that will appear on the May 8, 2010 Flatonia Municipal Ballot are as follows: Mayor — Scott Mica and Mark Eversole; Councilmember (2 places up for election) — James Longmire, Len Waska, Tyler Mica, Bryan Milson and Brad Cosson.

Brunner also reported that the Utility Billing Secretary/Municipal Court Clerk certified as a Municipal Court Clerk I in 2005 and completes her continuing education annually. Brunner also reported that Administrative Assistant Cheryl Sedlar also attends annual education to be able to be the Deputy Court Clerk. Brunner finally reported that Dale, Sedlar and she had all attended notary training as they all provide notary services to the community.

Economic Development

Economic Development Commission Chair Bob Duncan reported that the commission was currently working on a list of all of the businesses in Flatonia as well as a list of those entities that are 501(c)3 in the area. The Commission is also working on a relocation package for businesses and individuals who wish to relocate to Flatonia. Duncan also reported that Nick Dynis will be attending the I10 Corridor meetings on behalf of the commission. Duncan further reported that there had not been any business assistance packages awarded at this time.
