Police Chief's Report

Chief Noak presented the April 2010 Activity report for the Flatonia PD.

City Secretary Report

City Secretary Brunner reported that of the 744 registered voters for the City of Flatonia, 69 voted during early voting (7 of who voted during the extended hours mandated by state law), 221 voted on Election Day to give a total of 290 voters for this election. This is a 9% turnout for early voting and a 39% turnout overall. There was one provisional vote cast, but the Fayette County Elections Administrator has stated that it is not eligible for counting and as such is not included in the canvassed votes.

Code Compliance Officer Report

Code Compliance Officer Gregory Robinson reported that he had attended a Fire Wise Program on April 30th. This is a Fire Prevention Community Volunteer Program.

Economic Development Commission

Chair Bob Duncan reported that the Commission had not received any new incentive award applications since the last meeting. He also reported that the I10 Corridor Meeting would be hosted by the City and Chamber here on May 14th at Robert's Steakhouse. Duncan also reported that the Commission would be working on a prospective business package and is asking for suggestions on how the Economic Development Commission can better serve the Council.

Mark Eversole seconded the motion. None opposed. Motion carried. 5-2010.6 Kathy Collins motioned to waive the requirement for a sprinkler system for each of the buildings in the new City Warehouse Complex. Len Waska seconded the motion. None opposed. Motion carried. Kathy Collins motioned to approve the Flatonia Chamber of Commerce 5-2010.7 requested changes in the lease on the Civic Center. Mark Eversole seconded the motion. Jan Lahodny abstained. Len Waska opposed. Teri Wilks abstained. Kathy Collins and Mark Eversole voted for. Motion
